Notice Inviting Tender

The Kangra Central Co-operative Bank Limited invites sealed tenders for the empanelment of vendors for the "Supply & Installation of UPS Batteries" from Original Equipment Manufactures (OEM) / Authorized Dealer/ Distributor of OEM/ Authorized Business Partner of OEM.

Quotation should be sealed and superscribed with tender number and due date of submission and addressed to "The Managing Director, The Kangra Central Co-operative Bank Ltd (Head Office), Sehkar Jyoti Bhawan, Civil Lines, College Road, Dharamshala (HP) - 176215"

The sealed quotations should reach at the address given above, latest by 08.09.2017 upto 1:00 PM and it will be opened on the 08.09.2017 at 3:00 PM in the Conference Hall at Head Office of the Bank at Dharamshala in the presence of the bidder(s) or their authorized representative(s), who wish to be present at the scheduled date and time.

1. BID SUBMISSION PROCEDURE: - Bids should be submitted in two sealed envelops: -

Envelope 1: - It shall contain cost of Tender, Earnest Money Deposit (**EMD**), Bid Covering Letter & Technical Bid. This cover should be super-scribed as "**Technical Bid for UPS Batteries**" and comprise of : -

- Valid demand draft in favour of the Managing Director, The Kangra Central Cooperative Bank Limited, payable at Dharamshala for Rs. 1000/- being the cost of tender.
- ii. Valid demand draft in favour of the Managing Director, The Kangra Central Cooperative Bank Limited, payable at Dharamshala for Rs. 50000/- being the **EMD**.
- iii. Neatly typed **Bid Covering Letter** on the letterhead of the Bidder and duly signed by the authorized signatory in the proforma given in Section 5 post i.e. "Bid Covering Letter".
- iv. Neatly typed and duly signed **Technical Bid** by the authorized signatory along-with relevant documentary proof in support of claim as per proforma given at Section 6 post.

Envelope 2:- This cover should super-scribed as "COMMERCIAL BID for UPS Batteries" and contain neatly filled Commercially bid as per proforma given at Section 6 post.

- 2. **BID EVALUATION PROCESS:-** Bid evaluation process will be as follows:
- 1. **Opening of Technical Bid : -** Technical Bids will be opened on 08.09.2017 at 3:00 PM at conference Hall of "The Kangra Central Co-Operative bank Ltd., Head Office Dharamshala" in the presence of representatives bidder(s) who wish to be present.
 - 2. Opening and Evaluation of Commercial Bids :
 - i. Commercial Bids of only technically qualified bidders will be opened.
 - ii. The Bidders shortlisted/evaluated for opening of the Commercial Bids will be informed of the Date/Time/Venue of opening of the commercial Bids.
 - iii. L1 bidder of respective catagories of batteries(12V/42AH/SMF, 12V/65AH/SMF & 12V/100AH/SMF) becomes eligible for empanelment.

3. TERMS & CONDITION:-

3.1 BIDDER'S QUALIFICATIONS (GENERAL)

3.2 BIDDER'S QUALIFICATIONS (TECHNICAL)

- 3.3 The Bidder shall submit a copy of the tender document and addenda thereto, if any, with each page of this document should be signed and stamped to confirm the acceptance of the entire terms & conditions as mentioned in the tender document.
- 3.4 The Bidder shall deposit Rs. 1,000/- (Rupees One Thousand Only) in the form of a Demand Draft favoring The Kangra Central Cooperative Bank Limited payable at Dharamshala being

the cost of the tender document along with Bid in the manner as prescribed above.

- 3.5 <u>Earnest Money Deposit</u>: The bidder shall be required to submit the Earnest Money Deposit (EMD) for an amount of Rs. 50,000/- (Rupees Fifty Thousand only) by way of demand draft favoring "The Kangra Central Cooperative Bank Limited " payable at Dharamshala only.
- 3.6 EMD of empanelled Bidders will be retained as Performance Guarantee and will be returned at the end of empanelment period. No interest will be paid on Performance Guarantee/EMD amount.
- 3.7 The empanelment is for the supply of batteries during empanelled period against the requirement which may occur during this period. There is no binding on the Bank to procure batteries of any type during the empanelled period in case no requirement occur. Purchase order will be issued based on the actual requirement of the Bank during the next one year.
- 3.8 Bid(s) received without EMD, Tender Cost and not complying with above terms and conditions shall be liable for rejection.
- 3.9 Incomplete and Conditional bid will be treated as unresponsive and shall be rejected.
- 3.10 Unsuccessful Bidders' EMD will be returned as promptly as possible after bid evaluation.
- 3.11 Number of bidders to be empaneled by Bank will be decided dynamically and will depend upon the response of bidders.
- 3.12 Bidders, who becomes eligible for empanelment, has to submit an undertaking that they will supply the batteries as per the requirement of Bank on the offered price and terms & conditions for next one year from the date of empanelment.
- 3.13 The Bank reserves the right to accept or reject any bid partially or fully or annul the bidding process and reject all bids at any time prior to award of Purchase Order without assigning any reason, thereby incurring no liability to the affected Bidder(s). The Bank is under no obligation to inform the affected Bidder(s) of the ground for its action.
- 3.14 **Rates :-** The rates quoted shall remain firm throughout the period of contract and this contract will remain valid up to one year from the date of empanelment.
- 3.15 Taxes :- The rates quoted should be inclusive of the GST component. No GST would be paid if valid registration is not produced. All other taxes, fee, levy, insurance charges etc. would be borne by the Agency/Firm.
- 3.16 **Validity:** The quoted rates must be valid for period of 90 days from the date of closing of the tender. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If the bidder quotes the validity shorter than the required period, the same will be treated as unresponsive and it may be rejected.
- 3.17 Bidders should note that if the last date of submitting bids is declared a closed holiday by the Govt., the bids will then be submitted till 1.00 PM on next working date and will subsequently be opened on same day at 3.00 PM at designated place.
- 3.18 **Delivery :-** The delivery and installation period of the supplies should be within 30 days from the date of confirmed order from The Kangra Central Co Operative Bank Ltd.
- 3.19 **F.O.R Destination:-** At any Offices of the Bank with in the operational area i.e. Kangra, Una, Hamirpur, Kullu and Lauhal & Spiti districts of Himachal Pradesh.
- 3.20 Buy back price for 12V/120AH/SMF batteries will not account for commercial comparison. The Bank will however accept the maximum buy back price offered amongst the empaneled bidders for 12V/120AH/SMF batteries.
- 3.21 Warranty: This contract will include supply & installation of batteries with 2 years on-site

comprehensive warranty and support as per OEM from date of installation. It will also include service parts. The bidder will produce documentary proof of having 2 years warranty.

The manufacturing date of battery should not be older than three months from the date of delivery. Serial Number printed on warranty card should match with embossed serial number on battery supplied and during warranty period, the replacement of malfunctioning batteries should be done with new batteries not be older than three months from the date of delivery.

- 3.22 **Penalty**: If the supplier fails to supply and install on or before the stipulated time period, then a penalty at the rate of 1% per week of the total order value shall be levied subject to maximum of 10% of the total order value. The purchase order will be canceled and EMD (Performance Guarantee) will be forfeited.
- 3.23 **INSURANCE**:-The Bank will not pay for any insurance charges against loss or damage and it shall be purchased by the Bidder, in an amount equal to the exact value of the goods up to the delivery site on all risks basis, including war Risks and strike clauses etc.
- 3.24 **ARBITRATION:** All disputes, differences, claims and demands arising under or pursuant to or touching the contract shall be referred to the sole arbitrator to be appointed by the Managing Director, The Kangra Central Cooperative Bank Limited, Dharamshala, H.P. The award of the sole arbitrator shall be final and binding on both the parties under the provisions of the Arbitration and Conciliation Act, 1966 or by statutory modification/re-enactment thereof for the time being in force. Such arbitration shall be held at Dharamshala.
- 3.25 **CONFIDENTIALITY**: The Bidder shall not, and without the Bank's prior written consent, disclose the contract or any provision thereof, or any specification, plan, drawing, pattern, sample or information furnished by or on behalf of the Bank in connection therewith to any person other than a person employed by the Bidder in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 3.26 Payment Terms :- 100% Payment will be released with in 30 days on submission of :-
 - Invoice/Bill duly completed in all respect and accompanied with Installation report duly signed and stamped by the concerned office Incharge of The Kangra Central Co – Operative Bank Ltd.
 - Documentary proof or on OEM website of having 2 years warranty.

3.27 Applicable Law & JURISDICTION OF COURTS:

- The contract shall be governed by the laws and procedures established by Govt.
 of India, within the framework of applicable legislation and enactment made from
 time to time concerning such Commercial dealings / processing.
- Any disputes are subject jurisdiction of Competent Court and Forum in Dharamshala, Himachal Pradesh, India.
- 3.28 Force Majeure:- Any delay due to Force Majeure will not be attributable to the supplier.
