Reg: Notification regarding Elections


Sirs,


Meeting of the Executive body of union was held on 20/5/2013 at HO Dharamshala. It was resolved that as per the constitution of this union, it has completed its 3 year tenure on 16th May 2013 and elections to approved posts of President, General Secretary, Sr. Vice President & Joint Secretary may be held at Dharamshala on 16th June 2013 preceded by a General House at 9.30 AM on the same day. The details for smooth conduct of elections as resolved are given below.

1. Sh. H R Sharma Asstt. General Manager (IT) HO Dharamshala shall be the Returning Officer during the entire process of elections. He shall be assisted by an electoral committee comprising Sh. Ranjeev Thakur A.G.M HO Dharamshala , Sh. Ravinder Singh Thakur Gr-I HO Dharamshala & Sh. Amit Gupta.
2. Beside the electoral committee, Sh. H.S. Bhully A.G.M HO Dharamshala shall be the Presiding Officer on the day of the elections on 16/6/2013 and he shall be assisted by Sh. Satish Sharma Gr-I ZO Nagrota Bagwan & Sh. Rajan Sharma Gr-I (Dev) at the election venue for the smooth & fair conduct of elections.
3. After the General House, the election process shall commence at 11 AM sharp and last till 3 PM.
4. Nomination forms, which are being circulated herewith shall be filed by every interested member in person w.e.f 27th May to 5th June 2013. The same shall be filed/deposited with Sh. Ravinder Kumar Gr-I I&S section upto 5/6/2013 (5 PM) .
5. No candidate shall be allowed to file his/her nomination for more than one post. Scrutiny of all the nomination forms duly executed along with one proposer & one seconder shall be done by the above mentioned Electoral Committee and final list of eligible candidates for various posts shall be declared on 7th June 2013.
6. Last date for withdrawal of nominations is 10th June 2013 till 3PM and only those employees shall be allowed to participate who are regular union members. Any employee other than contractual employees, Daily Paid Workers & Part time Water Carriers, who is not a member can enroll him/herself as member by sending

an application to Sh. K.C. Thakur General Secretary before 31st May 2013.


7. Sh. Ashwani Kumar PCC I&S Section, Sh. Madan Lal PCC (HO), Sh. Kamlesh Kumar PCC (HO) & Sh. Kuldeep Kumar HCP (ZO Kangra) shall render ministerial services to the electoral committee on the day of the elections.
8. Voting for each post shall be held on secret ballott basis and shall continue till 3 PM on 16/6/2013.
9. In order to conduct free & fair elections the Returning Officer & the Electoral Committee shall be free to hire the services of relevant election officials posted with District administration.
10. The Returning Officer along with the Presiding Officer & other electoral committee members shall conduct the process of counting at 4.30 PM & thereafter declare the results after the satisfaction of all contestants.
11. Only the candidates and only one of their authorized representative shall be allowed to be present in the counting process.
12. Objections, if any, may be addressed to the Returning Officer & the decision of the Electoral Committee headed by the Returning Officer shall be final.
13. A community lunch (Dham) is also being organized on the day of the election and management of the same shall be done by Sh. K.C. Bhardwaj Gr-I Branch Office Dharamshala.






